COMMERCIAL HOOK-AND-LINE LICENSE TRANSFER APPLICATION

Such transfer must be documented on this form and approved by the Commissioner of Marine Resources. Upon approval, the person entering the commercial hook-and-line fishery shall purchase a commercial hook-and-line license in his own name. No license shall be transferred more than once per calendar year.
