Please read all instructions carefully!
Payment: Please make check or money order payable to Treasurer of Virginia. We do not accept credit or debit cards. If you are paying for the licenses of multiple people, please use a separate check or money order for each individual.

Discount: Don't forget about the vessel owner \& fishing guide license purchase discount. Example: To calculate the purchase of one resident 6 -pack charter license and a resident Class B Fishing Guide it would be: $\$ 190+\$ 100$ $=\$ 290$ with the owner/fishing guide discount the total cost is $\$ 190$ for both licenses.

Signature: Please make sure the front of the form is signed by the licensee/permittee verifying the physical (or 911) address and residency.

Codes: 800, 801, 805, 806 - For the purchase of a Head Boat or Charter Boat License, you must provide a copy of the current vessel registration or documentation for the boat you wish to licenses. To license multiple vessels, list all the vessel ID numbers on the lines provided on the front of the form. Each license must be purchased separately.

Codes: 810, 813, 811, 814 - For the purchase of a Class A or B Fishing Guide License, you must provide a copy of your current USCG Captain's License. Please list a primary vessel ID number on the line provided on the front of the form. Please note that the Class A Fishing Guide License is limited entry and only qualifying individuals may purchase this license. Remember, a MD Reciprocity Permit is required to use a Class A in MD waters.

Code: 812 - For the issuance of the Fishing Guide Reciprocity Permit, you must provide a copy of your current USCG Captain's License AND your current Maryland Fishing Guide License (FGR, FGN, TFL). You must also provide a copy of your primary vessel registration or documentation.

NOTE: TO BE A LEGAL CHARTER BUSINESS, THE GUIDE MUST HOLD A FISHING GUIDE LICENSE AND THE BOAT MUST HAVE A CHARTER PERMIT. Maryland charter license holders are fully covered under the Fishing Guide Reciprocity Permit.
